SPECIFIC MOBILITY REGULATIONS FOR STUDENTS IN THE UIB FACULTY OF MEDICINE

These provisions supplement the general mobility regulations at the UIB

- 1. Students applying for a mobility place shall be registered at the UIB at the time of their application and for the entire period of the place.
- 2. In order to request a place on a mobility programme, students must have passed the minimum number of credits required according to the specific programme regulations. In any event, students are recommended to have passed at least 120 credits prior to undertaking the mobility.
- UIB students may undertake a maximum of three semester-long stays throughout their degree, spending no more than two semesters at the same university.
- 4. The credit recognition proposal in the learning agreement must include a minimum of 18 credits per semester, although this number may be higher depending on the programme. In addition, a higher number of credits may also be a requirement at the destination university. In the SICUE programme, the minimum number of credits required is 24 credits per semester or 45 per full academic year. In exceptional cases, and upon approval from the person responsible for mobility at the destination centre, agreements that include credits below the established minimum for justified reasons (in case the student has fewer credits left to complete his or her studies) may be accepted.
- 5. The ECOE examination shall be taken at the UIB.
- 6. The Final Degree Project (TFG) must be tutored and defended at the UIB. Students undertaking a mobility stay at the UIB from other universities may not do their TFG at the UIB.
- 7. The subjects Clinical Management, Medical Ethics, and Legal Medicine and Toxicology shall not recognise studies taken at overseas universities.
- 8. Subjects previously failed at the UIB may not be passed by accreditation.
- 9. During the mobility period, students may not take subjects at the destination university and the UIB, except those they have previously failed at the UIB. Subjects taken at the UIB shall be governed in all aspects (schedule, assessment, etc.) by what is set out in the corresponding course guide. Each student is responsible for ensuring that s/he may perform the assessment activities as planned, and that s/he is able to fulfil the necessary requirements for passing the subject as set out in the corresponding course guide.
- 10. The minimum language level required to undertake an international mobility stay shall be as recommended or required by the destination university and be set out in the corresponding agreement. Students must fulfil this requirement at the time they make their application through UIBdigital.
- 11. In the event that no agreement has been signed between the UIB Faculty of Medicine and the institution where the mobility period is to take place (e.g. United Kingdom), students must contact the destination university directly and ask to be accepted as a visiting student. Once the destination centre accepts them, they may process their mobility authorisation at the UIB. Since there is no signed mobility agreement, students shall pay the tuition at the destination university. This option is not valid for mobility within Spain.

12. Students who undertake a mobility stay at an overseas healthcare centre must have a document accrediting coverage with a medical insurance policy, which may also be required to include civil liability. This document may be a requirement at the destination centre. This regulation also applies to students from other universities who undertake placements at the UIB.
